## Foundation Funding Opportunities

### ARTS AND HUMANITIES

#### NEW!!

#### The Endangered Language Fund Supports Projects to Document and Revitalize Languages.

The Endangered Language Fund provides grants for language documentation and revitalization, and for linguistic fieldwork. The work most likely to be funded is that which serves both the native community and the field of linguistics, although projects which have immediate applicability to one group and more distant applicability to the other will also be considered. Support for publication is a low priority, although it will be considered. Proposals can originate in any country. The language involved must be in danger of disappearing within a generation or two. Endangerment is a continuum, and the location on the continuum is one factor in our funding decisions.

Grant Amount: Grants range from \$2,000 to \$4,000.

Eligibility: Language activists and researchers from any country are eligible to apply. Awards can be made to institutions, but no administrative (overhead, indirect) costs are covered. Please note that many languages in the northwestern United States of America are NOT eligible for the Language Legacies program.

#### First Nations Development Institute Supports Native Language Immersion Programs.

First Nations Development Institute supports Native-controlled nonprofit organizations and tribal government programs actively supporting Native language-immersion and culture-retention programs. Through the Native Language Immersion Initiative grant program, First Nations seeks to build a dialogue and community of practice around Native language immersion programs and consensus on momentum for Native language programs. The target age is children to college-age students. Programs should be actively growing new speakers and have plans for assessment and evaluation in place to identify progression in student Native language acquisition. Priority will be given to programs with a long-term, community-based immersion plan. Funding can support curriculum development, technology access, instructional courses and materials, teacher training and other kinds of organizational infrastructure, all aimed toward achieving Native American fluency and academic proficiency.

Grant Amount: Grants of up to \$90,000 are available.

Eligibility: Eligible entities must be Native-controlled intuitions and organizations with an existing language-immersion program providing at least 20 hours per week per school year of Native American language instruction with at least 10 students.

**Chamber Music America Accepting Applications for the Commissioning and Performance of New Works by American Composers.**

Chamber Music America's (CMA) *Classical Commissioning Program* provides grants to professional U.S.-based presenters and ensembles whose programming includes Western European and/or non-Western classical and contemporary music. Grants are provided for the commissioning and performance of new works by American composers. The program supports works scored for 2–10 musicians performing one per part, composed in any of the musical styles associated with contemporary classical music. CMA seeks to fulfill its vision for the future, where people of all races, religions, genders, and abilities are able to fully participate in the performance, presentation, and enjoyment of the many styles of small ensemble music.

Grant Amount: Grants include a composer's fee of up to \$20,000, a \$1,000 honorarium for each ensemble member (up to ten) for rehearsing the new piece, and copying costs of up to \$1,000.

Eligibility: To be eligible, an ensemble must be a professional group based in the U.S. or one of its territories with a commitment to contemporary classical or world music; consist of "fixed" personnel and instrumentation or be part of a flexible roster or a collective that performs in varying configurations of no more than ten; perform as equal partners (in the case of a duo), rather than as soloist and accompanist, and consistently publicize itself as a duo; and be a CMA organization-level member. A presenter is eligible if it is based in the U.S. or one of its territories; is a 501(c)(3) or other not-for-profit organization; presents classical, contemporary, other music genres, and/or multidisciplinary performing arts programs; and is a CMA organization-level member. The composer must be a citizen or permanent resident of the U.S. In addition, s/he may be a member of the applicant's ensemble and may not appear on more than one application to a CMA commissioning program for the same grant period.

**NEW!!****Bloomberg Philanthropies Launches 2018 Public Art Challenge for U.S. Cities.**

Bloomberg Philanthropies announced the launch of the 2018 Public Art Challenge. Through the challenge, Mayors of U.S. cities with thirty thousand residents or more are invited to apply for funding to support temporary public art projects that address important civic issues. Submissions of dynamic works of art across all disciplines will be considered. Proposed projects will be evaluated on their ability to generate public-private collaborations, celebrate creativity and urban identity, and strengthen local economies.

Grant Amount: Grants of \$1 million dollars are available. At least three winners will be chosen in 2018 to execute their projects over a maximum of twenty-four months. Grants will cover project-related expenditures such as development, execution, and marketing, but will not fund 100 percent of project costs.

Eligibility: To be eligible, lead applicant must be submitted by the Mayor or chief executive of the host city on behalf of a collaboration between the city and an artist and/or arts organization. U.S. cities are required to have 30,000 residents or more to apply.

**NEW!!****The Kress Foundation Accepting Proposals for Conservation Grants.**

The Samuel H. Kress Foundation supports projects that illuminate European works of art and architecture from antiquity to the early 19<sup>th</sup> century. As part of that mission, the foundation's Conservation Grants Program provides support for the professional practice of art conservation.

Grants are awarded to projects that create and disseminate specialized knowledge, including archival projects, the development and dissemination of scholarly databases, documentation projects, exhibitions and publications focused on art conservation, scholarly publications, and technical and scientific studies. Grants are also awarded for activities that permit conservators and conservation scientists to share their expertise with both professional colleagues and broad audience through international exchanges, professional meetings, conferences, symposia, consultations, the presentation of research, exhibitions that include a prominent focus on materials and techniques, and other professional events.

Grant Amount: Grant amounts range between \$7,500 to \$100,000.

Eligibility: Grants are awarded to nonprofit institutions with 501(c)(3) status based in the United States, including supporting foundations of European institutions.

**Amphion Foundation Accepting Applications from Performing Musical Ensembles.**

The Amphion Foundation support and encourages the performance of contemporary concert music, particularly by American composers, through its support to performing and presenting organizations that have demonstrated sustained artistic excellence.

As part of this mission, the foundation is accepting applications for nonprofit performing ensembles for general operating support or for special projects. For the 2018 grant cycle, support will only be given to projects that begin between September 2018 and August 2019. (Under extraordinary circumstances, the foundation will consider projects that fall outside that period.)

Grant Amount: Grant amounts range from \$1,000 to \$7,500, although larger grants may be awarded to larger performing organizations with an extraordinary commitment to contemporary concert music or with a particularly significant project.

Eligibility: To be eligible, applicants must be a nonprofit amateur choral ensemble or youth choir performing contemporary classical music at an exceptionally high artistic level.

**The Jim Henson Foundation Invites Grant Applications for Puppet Theater.**

The Jim Henson Foundation awards grants annually for the creation and development of innovative works of puppet theater.

1. Production grants of \$7,000 are awarded for the production of new works to be presented in 2019.
2. Workshops grants of \$3,000 are awarded for the development and workshopping of productions. Workshop and Production grants can be combined over a two-year period for the greatest benefit to the piece.
3. Family Grants of \$4,000 fund the development of new and innovative work specifically for children, families, and teenagers.

Grants are made only for the development of new works of live puppet theater. The foundation does not award funds for the presentation or remounting of existing work. Grants cannot be applied retroactively, and substantial portions of a proposed project must take place after the funds are awarded.

Grant Amount: Grants range from \$3,000 to \$7,000.

Eligibility: To be eligible, applicants must be:

- Considered tax-exempt under Section 501(c)(3) of the Internal Revenue Code
- Applications from international collaborations are accepted, but the primary artist and fiscal sponsor must be American. Projects that only take place outside the United States are not eligible for funding.

Due Date: Letters of Intent are due March 12, 2018. Upon review, selected applicants will be invited to submit a full proposal by September 10, 2018.

### **Classics for Kids Accepting Applications to Add Fine String Instruments to Music Programs.**

The Classics for Kids Foundation provides matching grants to schools and nonprofit organizations to incorporate fine string instruments into their music programs. Classics for Kids Foundations believes that playing a stringed instrument can transform a child, giving them experiences and skills that can help make them more successful in life.

Grant Amount: Grants of up to \$5,000 are available. Grants must be matched with other funding.

Eligibility: To be eligible, public and private schools or nonprofit organizations must demonstrate need and a commitment to raising matching funds.

## **BASIC NEEDS**

### **The Lawrence Foundation Supports Human Services Projects and Other Programs.**

The Lawrence Foundation is focused on making grants to support environmental, human services, and other causes, although the foundation's interests are fairly diverse and may lead to funding in other areas on an occasional basis. The foundation makes both program and operating grants and does not have any geographic restrictions. However, requests to fund the following purposes are likely to be denied:

- Computers or software,
- Audio or video equipment,
- Designing and producing videos, kiosks or promotional material,
- Music programs or musical instruments,
- Gardening programs or equipment,
- Physical education programs or equipment,
- Recreational programs,

- Theatre arts or performing arts programs or equipment,
- Hospice or old age home programs,
- Churches,
- Religious, charter or magnet schools
- Individuals for any purpose,
- International organizations that do not have a qualified domestic 501(c)(3) representative,
- Political lobbying activities or other political purposes,
- Voter registration,
- Private foundations,
- Dinners, balls, or other ticketed events,

Grant Amount: Grant amounts not specified.

Eligibility: Nonprofit organizations that qualify for public charity status under section 501(c)(3) of the Internal Revenue Code or public schools and libraries are eligible for contributions or grants.

### **NEW!!**

**The World of Children Program Offering Awards to Individuals Making a Contribution to the Lives of Children.**

The World of Children recognizes and elevates those selfless individuals who make a difference in the lives of children across the globe, regardless of political, religious or geographical boundaries. These courageous leaders recognize that children are the world's most important asset. These Awards ensure that more children's lives will be touched, improved and changed forever.

The World of Children Awards honors individuals in the following categories:

- **Protection Award:** Recognizes individuals making extraordinary contributions to children so that they can live free from fear, abuse, and exploitation (including but not limited to trafficking, slavery, and sexual imposition). The award is designed to help more children live lives that are free and healthy.
- **Education Award:** Recognizes individuals making substantial contributions to children in the educational arena, including individuals who have made and are making education available to underserved populations, those who innovate new methods of learning and teaching, and those whose work creates educational opportunity for children who are challenged or disenfranchised.
- **Humanitarian Award:** Recognizes an individual who has made a significant contribution to children in the areas of education, social services, or humanitarian services. Nominees must have created, managed, or otherwise supported a sustainable program that has significantly



contributed to children's opportunities to be safe, to learn, and to grow; must be doing this work over and above their normal employment, or work for little or no pay; must have been doing this work for a minimum of ten years; and have an existing nonprofit organization in good standing that can receive grant funds.

- **Health Award:** Recognizes an individual who has made a significant contribution to children in the fields of health, medicine, or the sciences. Nominees must have created, managed, or otherwise supported a sustainable program that has significantly contributed to the improved health of children; must do this work over and above their normal employment, or work for little or no pay; must have been doing this work for a minimum of ten years; and must have an existing nonprofit organization in good standing that can receive grant funds.
- **Youth Award:** Recognizes youth that are making extraordinary contributions to the lives of other children. Nominees must be under the age of 21 by the nomination submission deadline; must have an existing nonprofit organization in good standing that can receive grant funds; and must have been doing this work for a minimum of three years by the submission deadline.

Grant Amount: Awards start at \$50,000.

Eligibility: Each award has distinct requirements, but most require affiliation with a nonprofit agency.

### **ALDI Stores Support Programs Promoting Healthy and Active Kids.**

- Public or private K-12 school.
- Faith-based organizations that benefit children in the community.

Due Date: Applications are accepted between February 1<sup>st</sup> and December 15<sup>th</sup> of each year. Applications are reviewed as they are received. Requests should be submitted four weeks prior to the date that the contribution is needed.

**A Little HOPE Supports Bereavement Services for Youth.**

A Little HOPE, Inc. grants funds to organizations that provide bereavement support services and grief counseling to children, teens and young adults, who have experienced the death of a parent, sibling or loved one, regardless of the circumstances of the death. A Little HOPE is focused on creating innovative initiatives. While the programs supported are diverse in their approach, all utilize the peer support group model to facilitate children's expression of painful and conflicted thoughts and feelings about the death of a loved one, without judgment. This is accomplished as children tell the story of what happened through physical play, art projects, music and/or journal writing. Distinct from other application processes, A Little HOPE asks that to be considered for a grant, an introductory email be sent that includes:

- Name of the program
- Website address
- Name of executive director
- Name of program director
- Location of program

Grant Amount: Grants amounts not specified.

Eligibility: Eligible applicants include nonprofit organizations.

Due Date: Emails will be accepted at any time. Grant applications are by invitation only and are sent to potential grant recipients during the month of October each year.

**The American Legion Child Welfare Foundation Seeks Proposals for Information Campaigns.**

The American Legion Child Welfare Foundation supports organizations that contribute to the physical, mental, emotional, and spiritual welfare of children. The foundation awards grants for the dissemination of information about new and innovative programs designed to benefit youth or information already possessed by well-established organizations. Projects must have the potential to help American children in a large geographic area (more than one state).

Grant Amount: Grant amounts will be determined on a project-by-project basis.

Eligibility: Eligible applicants include 501(c)(3) organizations and certain organizations that qualify as tax-exempt within the meaning of the Internal Revenue Service.

#### **The Amateur Radio Relay League Foundation Supports Youth Amateur Radio Projects.**

The Amateur Radio Relay League (ARRL) Foundation generally awards initial funding to organizations for new Amateur Radio related projects. The focus of the grant program is to support Amateur Radio organizations with programs to educate, license and support Amateur Radio activities with emphasis on youth-based activities.

The ARRL Foundation gives preference to groups that successfully conduct fundraising locally before submitting a grant application. Proposals with strong and ongoing fundraising initiatives are preferred. The ARRL Foundation does not fund emergency communications equipment vans, equipment or facilities. Groups seeking such funding are encouraged to contact local resources that have a stake supporting Amateur Radio's success. The ARRL Foundation does not fund ongoing operations or expenses. It is rare for the Foundation to award a grant for more than one year or to renew a prior grant.

Grant Amount: Grant amounts range from \$1,000 to \$3,000.

Eligibility: Eligible programs and projects must take place in the United States.

Due Date: Applications are accepted on an ongoing basis.

#### **The Kars4Kids Small Grants Program Educational Initiative to Improve Communities.**

The Kars4Kids Small Grant Program supports educational initiatives and youth development programs in North America. Fundable activities include libraries, afterschool programs, mentoring, exercise programs, weekend programming, incentives for continued reading and math work, and anti-bullying initiatives.

Grant Amount: Grant amounts range from \$500 to \$2,000.

Eligibility: Organizations with current tax-exempt status under section 501 (c)(3) of the Internal Revenue Code.

Due Date: Applications are accepted on an ongoing basis.

### The Union Pacific Foundation Accepting Applications for Community Development Programs.

The Union Pacific Foundation supports funding for direct services and efforts that build the capacity of organizations focused on the following causes:

1. **Safety:** Helping communities prevent and prepare for accidents and emergencies.
  - a. Eliminate risks and improve safe access to community spaces through infrastructure.
  - b. Prepare and equip citizens and emergency responders.
  - c. Help prevent crime and incidents of violence.
2. **Workforce Development:**
  - a. Put youth on right track and build foundational skills, especially in Science, technology, Engineering, and Mathematics (STEM) as well as necessary technical and life skills, to begin a trajectory toward these careers.
  - b. Raise awareness of, educate and prepare young adults for middle-skill jobs, for instance through community colleges, vocational and career training programs, workforce readiness initiatives, and programs that assist with job placement and/or on-the-job experience.

Eligibility: To be eligible, nonprofit organizations, must be recognized as tax-exempt under Section 501(c)(3) of the Internal Revenue Code.

**United States Conference of Mayors Announces the Availability of Funds for Community Stabilization, Economic Development, and Job Creation.**

Wells Fargo Bank and the Wells Fargo Foundation are teaming up with the U.S. Conference of Mayors (USCM) to offer the CommunityWINS<sup>SM</sup>(Working/Investing in Neighborhood Stabilization) Grant

Program. CommunityWINS<sup>SM</sup> will be administered by USCM to support local nonprofits in promoting long-term economic prosperity and quality of life for their community. The partnership is focused on strengthening and expanding communities, removing blight and rebuilding communities, recognizing outstanding leadership and innovative solutions, and identifying these initiatives and best practices.

Grants support the following:

- **Neighborhood stabilization:** Projects designed to stimulate growth and stability while assisting in the removal of blight and the rebuilding of neighborhoods
- **Economic development:** Projects designed to promote business development
- **Job creation:** Projects designed to aid in local job creation or assist in job training

Grant Amount: Grants of up to \$300,000 are available, and are based on the size of the community.

Eligibility: Every member city of the USCM is eligible to apply for the 2018 CommunityWINS Grant Program. A city may nominate up to three eligible nonprofit organizations of the city's choice to apply. The eligible nonprofits must represent a U.S. based IRS qualified charitable 501(C)(3) organization with a valid tax identification number.

### **The Pop Culture Collaborative Offers Rapid Response Grants for Immediate Social Justice Goals.**

The Pop Culture Collaborative is an innovative hub for high impact partnerships and grants designed to help organizations and individuals leverage the reach and power of pop culture for social justice goals. The "Pop Up" Rapid Response Grants are designed to support a short-term project developed in connection to a recent or upcoming acute political or cultural time hook and must be intended to reach an audience of more than a million people or engage artists, producers, and/or organizers that do so.

Funded projects must impact, support, or connect with at least one of these community groups: people of color, immigrants, refugees, or Muslims. They can work to support initiatives that build movements, drive campaigns, produce stories, and leverage mass media and entertainment media to drive positive narrative and social change in popular culture. The Administration for Children and Families (ACF) announces funding Native American Language Preservation and Maintenance (P&M) programs. The purpose of the P&M program is to assist Native Americans in ensuring the survival and vitality of Native American languages. ANA supports locally determined projects that achieve community goals through specific, measurable outcomes. All P&M grants must have a start date of July 1. The Native Language Preservation and Maintenance program provides funding for projects to support assessments of the status of the native languages in an established community, as well as the planning, designing, restoration, and implementing of native language curriculum and education projects to support a community's language preservation goals.

Native American communities include American Indian tribes (federally-recognized and non-federally recognized), Native Hawaiians, Alaskan Natives, and Native American Pacific Islanders.

The National Endowment for the Humanities is now accepting applications for the Challenge Grants program. The goal of this program is to strengthen the institutional base of the humanities by enabling infrastructure development and capacity building. Grants aim to help institutions secure long-term support for their core activities and expand efforts to preserve and create access to outstanding humanities materials. Programs that involve collaboration among multiple institutions are eligible, but one institution must serve as the lead agent and formal applicant of record. Through these grants, organizations can increase their humanities capacity with spend-down funds that generate expendable earnings to support and enhance ongoing program activities.

Eligible activities include the documentation of cultural heritage materials that are lost or imperiled; the preservation and conservation of humanities materials; and the sustaining of digital scholarly infrastructure. Challenge grants may also provide capital directly supporting the purchase of equipment and software; the design, purchase, construction, restoration, or renovation of facilities needed for humanities activities; and collections sharing. Such direct expenditures bring long-term benefits to the institution and to the humanities more broadly. Grantee institutions may also expend to defray costs of fundraising to meet the NEH challenge. Challenge grant funds (both federal and nonfederal together) must enhance the humanities in the long term. Challenge grant funds should not merely replace funds already being expended, but instead should reflect careful strategic planning to strengthen and enrich an institution's humanities activities. Institutions may use challenge grant funds to meet both ongoing and one-time humanities-related costs, provided that the long-term benefit of the expenditure can be demonstrated.

Grant Amount: Grant amounts of up to \$1,000,000 are available.

Eligibility: Applications are welcome from colleges and universities, museums, public libraries, research institutions, historical societies and historic sites, scholarly associations, state humanities councils, and other nonprofit humanities entities.

### **The National Endowment for the Arts Supports Small and Mid-Sized Organizations that Extend the Reach of the Arts to Underserved Populations.**

The National Endowment for the Arts through the Challenge America grant category offers support primarily to small and mid-sized organizations for projects that extend the reach of the arts to underserved populations -- those whose opportunities to experience the arts are limited by geography, ethnicity, economics, or disability. Age alone (e.g., youth, seniors) does not qualify a group as underserved; at least one of the underserved characteristics noted above also must be present.

Grants are available for professional arts programming and for projects that emphasize the potential of the arts in community development. This category encourages and supports public engagement with, and access to, various forms of excellent art across the nation. The involvement of experienced artists and arts professionals is essential. Each applicant must present a straightforward project that reflects only one of the three project types below. Grants are available only for:

- Guest Artist, which refers to an arts event or events that will feature one or more guest artists. The involvement of experienced artists and arts professionals is essential.
- Cultural Tourism, specifically the unified promotion of community-wide arts activities and/or the development of cultural tourism products to enhance public engagement with arts and culture in communities and in cultural districts (including the marketing and promotion of arts and culture to populations that have been historically underserved).
- Public Art Projects, community-based and professionally directed. Although many kinds of art projects take place in the public realm, for the Challenge America category, the Public Art project type is intended to support primarily visual arts projects, which may be temporary or permanent, such as murals, sculptures, multi-media, or environmental art, developed through a meaningful community engagement process. Evidence of community involvement should be apparent in the planning, design, or fabrication of the work, and should include a professional lead artist.

Partnerships can be valuable to the success of these projects. While not required, applicants are encouraged to consider partnerships among organizations, both in and outside of the arts, as an appropriate way to engage with the identified underserved audience. To ensure that Challenge America funding reaches new organizations and communities, the National Endowment for the Arts has implemented a policy to limit consecutive-year funding.

Grant Amount: Grant amounts are for a fixed amount of \$10,000. Matching funding of \$10,000 is required.

Eligibility: To be eligible, the applicant organization must:

- Meet the National Endowment for the Arts' "Legal Requirements" including nonprofit, tax-exempt status at the time of application. (All organizations must apply directly on their own behalf. Applications through a fiscal agent are not allowed. See more information on fiscal sponsors.)
- Have a three-year history of arts programming prior to the application deadline.
- Have submitted acceptable Final Report packages by the due date(s) for all National Endowment for the Arts grant(s) previously received.

### **The National Archives and Records Administration Seeks Proposals to Publish Historical Records.**

The National Archives and Records Administration, through the National Historical Publications and Records Commission (NHPRC), seeks proposals to publish documentary editions of historical records. Projects may focus on the papers of major figures from American history or cover broad historical movements in politics, social reform, business, military, the arts, and other aspects of the national experience. The historical value of the records and their expected usefulness to broad audiences must justify the costs of the project.

The goal of this program is to provide access to, and editorial context for, the historical documents and records that tell the American story. Applicants should demonstrate familiarity with the best practices recommended by the Association for Documentary Editing or the Modern Language Association Committee on Scholarly Editions. All new projects (those which have never received NHPRC funding) must publish a digital edition which provides online access to a searchable collection of all documents. (Ebooks or volumes in PDF do not qualify for the purposes of this grant program.) New projects may also prepare print editions as part of their overall publishing plan, but the contents of those volumes must be published online within a reasonable period of time following print publication.

The NHPRC encourages projects to provide free access to online editions. Projects that do not have definitive plans for digital dissemination and preservation in place at the time of application will not be considered. Grants are awarded for collecting, describing, preserving, compiling, transcribing, annotating, editing, encoding, and publishing documentary source materials online and in print. Because of the focus on documentary sources, grants do not support preparation of critical editions of published works unless such works are just a small portion of the larger project. All applicants should be aware that the application process is highly competitive.

Grant Amount: Grants of up to \$200,000 are available.

Eligibility: Eligible applicants include:

- U.S. nonprofit organizations or institutions
- U.S. colleges, universities, and other academic institutions
- State or local government agencies

**The Veterans Employment and Training Service Supports Local Stand Down Events to Assist Homeless Veterans.**

The Veterans Employment and Training Service supports local Stand Down (SD) events that assist homeless veterans by providing a wide variety of employment, social, and health services. Stand Down grant funds must be used to enhance employment and training opportunities or to promote the self-sufficiency of homeless veterans through paid work. Grant amounts are based on the length of the event, which may be one or multiple days. Grants may be awarded to multiple organizations that conduct SD events in the same general area so long as there is no commingling of federal funds.

Grant Amount: Grant amounts range from \$7,000 to \$10,000.

Eligibility: Eligible applicants include State and Local Workforce Development Boards, Veteran Service Organizations, local public agencies, tribal governments, and non-profit organizations including community and faith-based organizations. Organizations registered with the Internal Revenue Service as 501(c)(4) entities are not eligible to apply for this funding opportunity.

Due Date: Stand Down funding is a non-competitive grant awarded on a first-come, first-served basis until available annual funding is exhausted. Applications are accepted and processed when additional funds become available.

**The Department of Housing and Urban Development Accepting Collaborative Applications to Prevent and End Youth Homelessness.**

The Department of Housing and Urban Development (HUD) will select up to 11 communities to participate in the Youth Homelessness Demonstration Program (YHDP) to develop and execute a coordinated community approach to preventing and ending youth homelessness. Five of the 11 selected communities will be rural communities. Only Continuum of Care (COCs) Collaborative Applicants may apply and Communities represented by the CoC Collaborative Applicant must include a youth collaboration board, the local or state public child welfare agency, and a broad array of other partners. Selected projects will develop and implement a Coordinated Community Plan to prevent

and end youth homelessness. All project types allowed under the CoC Program to support homeless and at-risk youth, as well as innovative project types that may require a waiver of CoC Program or McKinney-Vento Act requirements are allowed.

The purpose of the YHDP is to learn how communities can successfully approach the goal of preventing and ending youth homelessness by building comprehensive systems of care for young people rather than implementing individual or unconnected projects that serve this population. In order to effectively implement a system that addresses the needs of youth experiencing homelessness, CoCs must understand the subgroups of homeless youth experiencing homelessness and the unique challenges they face within their communities. Additionally, CoCs must ensure that the appropriate type of housing assistance and level of services that are effective in providing safe and stable housing are available within the community and must reach out and partner with a comprehensive set of traditional and non-traditional youth homelessness stakeholders that

CoCs must incorporate the experiences of homeless or formerly homeless unaccompanied youth—which is vital to understanding the needs, strengths, and perspectives of the youth in the community—and incorporate those understandings into the YHDP coordinated community plan and awarded projects. All of this will require CoCs to use innovative practices to design better projects and strong comprehensive plans to prevent and end youth homelessness.

- **Stable Housing:** Youth or pregnant and parenting youth and their dependent children will transition to safe and stable housing that appropriately matches their level of need after leaving a TLP/MGH to include: rapid re-housing, permanent supportive housing, moving in with family, personal safety, residential treatment center or substance abuse treatment facility

Grant Amount: Grant amounts range up to \$200,000.

- Establishing and facilitating a planning team of juvenile justice facilities staff and agency representatives, law enforcement, emergency management officials, medical and mental health experts, emergency medical services providers, prosecutors, defense attorneys, probation officers, juvenile and family court administrators, child welfare administrators, education partners, public works agencies, information technologists, and other key partners, to design and implement the emergency plan.
- Addressing gaps in, updating, and publishing the emergency preparedness plan.
- Conducting vulnerability assessments and identifying essential functions.
- Establishing agreements or contracts with organizations and professionals that can provide additional and necessary support during and following an emergency (e.g. educators, mental health professionals, and other support staff).
- Conducting assessment(s) of facility and staff preparedness for an emergency including a review of communication procedures, facility functioning, and staffing plans.
- Engaging staff, youth, and family members in training for emergency preparedness including cross-training, conducting drills, and exercises, as appropriate.
- Developing web-based services that the facility will use in case of an emergency (cloud-based facility backup files, notification services for families and partner agencies, and a communication system for youth to use in maintaining contact with family members).
- Purchasing of supplies or equipment for emergency preparedness (e.g. medical supplies, makeshift beds, generators, and communication equipment).

This program will support the development, improvement, and/or implementation of emergency planning activities for state, tribal, county, and local juvenile justice residential facilities.

Grant Amount: Grant amounts range from \$50,000 to \$350,000.

Eligibility: Eligible applicants are limited to states (including territories), units of local government, 1 federally recognized tribal governments as determined by the Secretary of the Interior, nonprofit organizations<sup>2</sup> and for-profit organizations (including tribal nonprofit and for-profit organizations), and institutions of higher education (including tribal institutions of higher education). A coalition is defined as a community-based formal arrangement for cooperation and collaboration among groups or sectors of a community in which each group retains its identity, but all agree to work together toward a common goal of building a safe, healthy, and drug-free community. DFC grant award recipients also referred to as 'recipients', are expected to conduct the day-to-day operations of the grant program. DFC recipients are not permitted to serve as a conduit for DFC funds passing through them or to another agency. Coalitions receiving DFC funds are expected to work with leaders in their communities to identify and address local youth substance use problems and create sustainable community-level change.

Grant Amount: Grant amounts range up to \$125,000 per year.

Eligibility: Eligible applicants are community-based coalitions addressing youth substance use that have never received a DFC grant.

Successful applicants are expected to submit program plans that agree to use medically accurate information referenced to peer-reviewed publications by educational, scientific, governmental, or health organizations; implement an evidence-based approach integrating research findings with practical implementation that aligns with the needs and desired outcomes for the intended audience; and teach the benefits associated with self-regulation, success sequencing for poverty prevention, healthy relationships, goal setting, and resisting sexual coercion, dating violence, and other youth risk behaviors such as underage drinking or illicit drug use without normalizing teen sexual activity.

Grant Amount: Grant amounts will likely range from \$300,000 to \$450,000.

Eligibility: Eligible applicants include:

- Special district governments
- City or township governments
- Nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education
- Private institutions of higher education
- Small businesses
- Others

### **The California Natural Resources Agency Announces Funding for Urban Greening Projects.**

The California Natural Resources Agency is pleased to announce the open solicitation period for the Urban Greening Grant Program. Eligible urban greening projects will reduce greenhouse gas (GHG) emissions and provide multiple additional benefits, including, but not limited to, a decrease in air and

water pollution or a reduction in the consumption of natural resources and energy. Eligible projects will result in the conversion of an existing built environment into green space that uses natural and green infrastructure approaches to create sustainable and vibrant communities. A competitive project will maximize opportunities to reduce GHG emissions through project design and implementation and will incorporate green infrastructure solutions that improve the sustainability and function of existing urban hardscapes and landscapes.

Examples of eligible urban greening projects include, but are not limited to, the following:

- Establishment, enhancement, and expansion of neighborhood parks and community spaces
- Greening of public lands and structures, including schoolyards, and which may include incorporation of riparian habitat for water capture and provide for other public and wildlife benefits
- Green streets and alleyways

All eligible projects must result in GHG reductions by including at least one of the following activities:

- Sequester and store carbon by planting trees
- Reduce building energy use by strategically planting trees to shade buildings
- Reduce commute vehicle miles traveled by constructing bicycle paths, bicycle lanes or pedestrian facilities that provide safe routes for travel between residences, workplaces, commercial centers, and schools.

In addition to reducing greenhouse gas emissions, all projects must achieve measurable benefits. Per statute, all projects must acquire, create, enhance, or expand community parks and green spaces, and/or use natural systems or systems that mimic natural systems to achieve multiple benefits.

Grant Amount: Award amounts not specified.

Eligibility: Eligible applicants must be a city, county, nonprofit organization, Joint Powers Authority or a Special District. 75% of all available funding will be awarded to projects within and benefiting disadvantaged and low-income communities
