The Lovett Foundation Supports Theater by Elementary School Students in a School Drama Program.

The Lovett Foundation supports school drama productions for elementary school students in grades 1-5.

Grant Amount: Grant amounts range from \$2,000 to \$3,000.

<u>Eligibility:</u> American elementary schools with tax exempt status from the IRS as 501(c)(3) are eligible to apply.

The Awesome Foundation Supports Ideas and Projects by People with Disabilities.

The Awesome Foundation supports ideas and projects by people with disabilities through the Awesome Disability chapter. Makers, artists, writers, and others with disabilities are invited to apply for micro-grants. Applications are reviewed by the Awesome Disability trustees every month.

Grant Amount: Grant amounts of up to \$1,000 are available.

Eligibility: Applicants should identify as a person with a disability.

<u>Due Date:</u> Applications are accepted from the 1st through the 15th of every month.

#### NEW!!

The Kress Foundation Accepting Applications for Digital Resources Program.

The Samuel H. Kress Foundation's Digital Resources program is intended to foster new forms of research and collaboration and new approaches to teaching and learning art history. Grants will be awarded for the digitization of important visual resources (especially art history photographic archives) in the areas of pre-modern European art history; for promising initiatives in online publishing; and for innovative experiments in the field of digital art history. The program does not typically support the digitization of museum object collections.

Grant Amount: Grant amounts range from \$12,000 to \$70,000.

<u>Eligibility:</u> To be eligible, applicants must be a nonprofit institution with 501(c)(3) status based in the United States.

Due Date: October 1, 2018

# The J.M. Kaplan Fund Supports Nonfiction Book Publishing Projects.

The J. M. Kaplan Fund supports publication of nonfiction books that concern the arts, history, and the natural and built environment. This grant funding is one of the very few philanthropic programs that specifically support printed and illustrated books. The program seeks work that appeals to an informed general audience; demonstrates evidence of high standards in editing, design, and production; promises a reasonable shelf life; might not otherwise achieve top quality or even come into being; and "represents a contribution without which we would be the poorer."

Funds may be used to support writing, research, editing, design, indexing, photography, illustration, and/or printing and binding.

<u>Grant Amount:</u> Grant amounts range from \$1,500 to \$15,000. Applications are reviewed by a group of scholars, publishers, and individuals; they collectively identify the projects that receive grants.

<u>Eligibility</u>: Applicants must be a 501(c)(3) organization. Trade publishers and public agencies may apply for grants in partnership with an eligible nonprofit sponsor.

#### The Fender Music Foundation Announces Availability of Musical Equipment for Music Instruction Programs.

The Fender Music Foundation (FMF) awards instruments and equipment to eligible nonprofit music instruction programs. The donated items are lightly used, blemished, or otherwise imperfect and have been collected by the foundation from manufacturers and retailers.

The FMF currently is awarding acoustic guitars, electric guitars, acoustic-electric guitars, bass guitars and the equipment necessary to play them. In addition, other traditional music instruments, including string instruments, woodwind instruments, brass instruments, percussion instruments, and keyboards, are sometimes available. DJ equipment and computers are not available.

To qualify as a music instruction program, participants in the program must be learning how to make music and the program must fit into one of the following categories: in-school music classes, in which the students make music; afterschool music programs that are not run by the school; community music programs that offer music instruction to community members; and music therapy programs in which the participants make the music.

**Grant Amount:** Musical instrument donations.

<u>Eligibility:</u> Applicants must be music instruction programs at public schools or as operated by a 501(c)(3) tax-exempt organizations as recognized by the Internal Revenue Service.

<u>Due Date:</u> Applications are accepted on an ongoing basis.

#### The Kurt Weill Foundation Accepting Applications for Grant Music Program.

The Kur Weill Foundation for Music supports and promotes the understanding of the life and works of composer Kurt Weill (1900-1950) and Marc Blitzstein(1005-1963) and preserving the legacies of Weill and his wife, acre-singer Lotte Lenya (1998-1981).

The foundation awards grants to individuals and nonprofit organizations for performances of musical works by Weill and Blitzstein; for scholarly research pertaining to Weill, Lenya, Marc Blitzstein; and for relevant educational initiatives. To that end, the foundation is accepting applications for projects and performances taking place on or after January 1, 2019, and before July 1, 2020.

**Grant Amount:** Grant amounts are not specified.

<u>Eligibility:</u> Individual artist and nonprofit organizations that qualify for public charity status under section 501(c)(3) of the Internal Revenue Code are eligible to apply.

#### **BASIC NEEDS**

#### The Walmart Foundation Accepting Applications for Services Aimed at Low-Income Populations.

The Walmart Foundation is now accepting applications through its Community Grant Program for a variety of programs, including those focused on basic needs like hunger relief and services for low-income individuals. Applicants' organizational goals must fall in one of the following eight areas:

- Hunger relief and healthy eating: Providing Federal or charitable meals/snacks for lowincome individuals and families in the United States
- **Health and human service:** Providing medical screening, treatment, social services, or shelters for low-income individuals and families in the United States
- **Quality of life:** Improving access to recreation, arts or cultural experiences for low-income individuals and families in the United States
- **Education:** Providing afterschool enrichment, tutoring or vocational training for low-income individuals and families in the United States
- **Community and economic development:** Improving local communities for the benefit of low-income individuals and families in the United States

- **Diversity and Inclusion:** Fostering the building of relationships and understanding among diverse groups in the United States
- **Public Safety:** Supporting public safety programs through training programs or equipment in the United States
- **Environmental sustainability:** Preventing waste, increasing recycling or supporting other programs that work to improve the environment in the United States

Applicants submit to local facilities for review by the facility manager.

Grant Amount: Grant amounts range from \$250 to \$5,000.

Eligibility: Eligible applicants include:

- An organization holding a current tax-exempt status under Section 501(c)(3), or (19) of the
  Internal Revenue Code, listed on the IRS Master File and conduct activities within the United
  States. This excludes nationally sponsored organizations: American Cancer Society, American
  Diabetes Association, American Heart Association, Children's Miracle Network and United
  Way;
- A recognized government entity: state, county, or city agency, including law enforcement or fire departments, that are requesting funds exclusively for public purposes;
- A K-12 public or private school, charter school, community/junior college, state/private college or university; or
- A church or other faith-based organization with a proposed project that benefits the community at large such as food pantries, soup kitchens, clothing closets, etc.

<u>Due Date</u>: The 2018 grant cycle began on February 1, 2018, and the application deadline is Dec. 31, 2018. Applications may be submitted at any time during this funding cycle. Applications will only remain active in the system for 90 days, and at the end of this period, they will be automatically rejected.

# **CHILDREN, YOUTH, AND FAMILY**

#### NEW!!

The Global Fund for Children Supports Programs that Improve the Lives of Vulnerable Children and Youth.

The Global Fund for Children supports organizations creating sustainable improvement in the lives of vulnerable children and youth. Organizations should also serve as a resource or model for other organizations. Organizations and grantee partners must focus on the most vulnerable populations, or those who are economically and socially outside the reach of mainstream services and support, including street children, child laborers, AIDs orphans, sex workers, hard-to-reach rural populations, and other vulnerable or marginalized groups.

Priority will be given to organizations that engage children and youth as active participants in their own growth and development, rather than as passive recipients of services.

Grant Amount: Grant amounts not specified.

<u>Eligibility:</u> All applicant organizations or sponsoring agencies must be exempt from federal taxation under the Internal Revenue Code Section 501(c)(3). If the political context makes legal registration unfeasible, the organization must demonstrate nonprofit equivalency. There is no start-up funding for the creation of a new organization.

Organizations are selected based on the following criteria:

- Appropriate size and stage of development: Prospective grantee partner's annual budget should not exceed \$200,000. In most cases, new grantee partners have budgets in the \$25,000 to \$75,000 range. The aim is to identify organizations at a relatively early stage of development.
- Direct involvement with children and youth: Perspective grantee partners must work directly with children and youth. Foundation does not support groups engaged exclusively in advocacy or research.
- Capable management: Grantee partners must have systems and processes for ensuring responsible management of funds. At a minimum, an organization must have basic accounting and reporting systems as well as phone and email access.
- Local Leadership: Grantee partners must be led by individuals who live and work in the community. We prioritize organizations whose leaders were born and raised in the community they serve.

<u>Due Date</u>: Organizations can submit an organizational profile at any time. Those who meet criteria will be invited to submit a full proposal.

#### NEW!!

The Caplan Foundation for Early Childhood Invites Letters of Intent.

The Caplan Foundation for Early Childhood supports innovative projects and programs with the potential to significantly enhance the development, health, safety, education, and/or quality of life of children from infancy through five years of age.

To that end, the foundation provides funding in the areas of early childhood welfare, early childhood education and play, and parenting education.

• Early Childhood Welfare: Children can only reach their full potential when all aspects of their development –intellectual, emotional and physical are supported. Providing a safe and nurturing environment for infants and preschoolers is essential, as is imparting to them the

skills of living in a culturally diverse world. To that end, the foundation supports programs that research best child-rearing practices and identify models that can provide creative, caring environments in which all children can thrive.

- Early Childhood Education and Play: Research shows that children need to be stimulated as well as nurtured early in life if they are to succeed in school, work and life. The preparation relates to every aspect of a child's development, and everywhere a child learns-at home, in childcare settings and in preschool. The foundation seeks to improve the quality of both early childhood teaching and learning through the development of innovative curricula and research-based pedagogical standards, as well as the design of imaginative play materials and learning environments.
- **Parent Education:** To help create nurturing environments for their children, the foundation supports programs that teach parents about developmental psychology cultural child-rearing differences, pedagogy, issues of health, prenatal care, and diet, as well as programs that provide both cognitive and emotional support to parents.

Grant Amount: Grant range between \$20,000 to \$100,000.

<u>Eligibility:</u> To be eligible, applicants must be considered a nonprofit, tax-exempt organization under Section 501(c)(3) of the Internal Revenue Code.

<u>Due Date:</u> Letters of Intent are due May 31, 2018.

# The Rosalyn F. Jaffe Awards Accepting Nominations for Pioneering Individuals at the Head of Organizations Committed to Women and Children.

Sponsored by the Ascena Foundation, the Roslyn S. Jaffe Awards program provides financial awards to everyday heroes who are making the world a better place for women and girls, specifically in the areas of health, education, social reform, and esteem.

Anyone can nominate themselves or a peer at any eligible organization for a chance to the win the Jaffe Award. Nominees who meet the eligibility requirements and complete the application process will be evaluated by a panel of judges, who will apply the following criteria:

- **High impact** The nominee's Organization highly impacts low- to middle-income women and/or children in the US and its work has resulted in clear benefits to these populations.
- Innovative & Responsive Approach The nominee's Organization has an innovative and entrepreneurial approach that addresses a challenge and its vision in a unique way. The Organization is also driven by its efforts to identify community needs, and, in response, build programming and services to affect those needs.

- **Off the Grid** At the time when nominees are evaluated in this contest, the Organization and its programming are not widely known, and are positioned to leverage the funding and/or the visibility provided should it win a Jaffe Award.
- **Scalable** The Organization can be expanded/replicated and applied to other locations.
- High Caliber of Leadership The leadership of the nominee's Organization—including the nominee—has the ability to create, advocate, and influence the Organization's vision.

Prizes will be awarded to the winning nominee's organization or fiscal sponsor.

<u>Grant Amount:</u> The grand-prize winner's organization (or fiscal sponsor, if applicable) will receive a \$100,000 award. The organization of each runner-up (or fiscal sponsor) will receive a \$25,000 award.

<u>Eligibility:</u> Nominees must be a legal resident of the United States; at least 18 years of age on the date of nomination; and the creator or founder of a social impact organization with 501(c)(3) tax-exempt status from the Internal Revenue Service. The nominee also must be the organization's principal decision maker in management and development matters. In addition, the organization must be independent and autonomous and must not be substantially supported by, or serve the purpose of promoting, religious or political organizations or beliefs.

#### The American Legion Child Welfare Foundation Announces Funding to Support Best and Promising Practices.

The <u>American Legion Child Welfare Foundation</u> supports organizations that contribute to the physical, mental, emotional, and spiritual welfare of children. The foundation awards grants for the dissemination of information about new and innovative programs designed to benefit youth or information already possessed by well-established organizations.

**Grant Amount:** Grant amounts will be determined on a project-by-project basis.

<u>Eligibility:</u> To be eligible, applicants must be considered a nonprofit, tax-exempt organization under Section 501(c)(3) of the Internal Revenue Code. Projects must have the potential for helping American children in a large geographic area (i.e., more than one state).

#### ALDI Stores Support Programs Promoting Healthy and Active Kids.

ALDI Stores, through the ALDI Smart Kids Program, support nonprofit organizations, public agencies, K-12 schools, and faith-based organizations that promote kids being active and healthy in the communities where ALDI stores are located. Grants and gift cards are provided to local

Grant Amount: Grants amounts range from \$100 to \$5,000.

<u>Eligibility:</u> Organizations must qualify as one of the following:

- 501(c)(3) tax-exempt organization.
- Public funded service agency, such as police or fire.
- Public or private K-12 school.
- Faith-based organizations that benefit children in the community.

<u>Due Date:</u> Applications are accepted between February 1<sup>st</sup> and December 15<sup>th</sup> of each year. Applications are reviewed as they are received. Requests should be submitted four weeks prior to the date that the contribution is needed.

#### A Little HOPE Supports Bereavement Services for Youth.

A Little HOPE, Inc. grants funds to organizations that provide bereavement support services and grief counseling to children, teens and young adults, who have experienced the death of a parent, sibling or loved one, regardless of the circumstances of the death. A Little HOPE is focused on creating innovative initiatives. While the programs supported are diverse in their approach, all utilize the peer support group model to facilitate children's expression of painful and conflicted thoughts and feelings about the death of a loved one, without judgment. This is accomplished as children tell the story of what happened through physical play, art projects, music and/or journal writing. Distinct from other application processes, A Little HOPE asks that to be considered for a grant, an introductory email be sent that includes:

- Name of the program
- Website address
- Name of executive director
- Name of program director
- Location of program

**Grant Amount:** Grants amounts not specified.

Eligibility: Eligible applicants include nonprofit organizations.

<u>Due Date:</u> Emails will be accepted at any time. Grant applications are by invitation only and are sent to potential grant recipients during the month of October each year.

The American Legion Child Welfare Foundation supports organizations that contribute to the physical, mental, emotional, and spiritual welfare of children. The foundation awards grants for the dissemination of information about new and innovative programs designed to benefit youth or information already possessed by well-established organizations. Projects must have the potential to help American children in a large geographic area (more than one state).

Grant Amount: Grant amounts will be determined on a project-by-project basis.

<u>Eligibility:</u> Eligible applicants include 501(c)(3) organizations and certain organizations that qualify as tax-exempt within the meaning of the Internal Revenue Service.

#### NEW!!

The Rockefeller Foundation and Chan Zuckerberg Initiative Announce Funding for Community-Driven Approach to Expanding Economic Opportunity.

The Rockefeller Foundation and Chan Zuckerberg Initiative have announced the launch of the Communities Thrive Challenge, a \$10 million funding opportunity to find and support successful community-driven approaches to expanding economic opportunity for low-income and financially insecure people and communities across the United States. Through a nationwide search, the challenge will identify up to eighty organizations with a proven track record and provide up to ten of them with \$1 million grants, technical assistance, and an opportunity to share their stories on the national stage. The challenge will take place over a nearly six-month period and include two review rounds and site visits for finalists. Every organization that submits an application will be asked to review and score five other applications against four main criteria:

- **Impact:** Are there demonstrated results, either through internal or external information or data, that indicate the approach has improved or will improve the lives of target communities? Does the proposal address a significant and/or urgent problem that the community is facing in terms of economic security, mobility, and/or opportunity?
- **Scale:** Could this approach be effective on a larger scale and/or become a model for other organizations, policies, or movements? Is the applicant organization well-positioned to help scale this approach?
- **Community-Based/Informed**: Does the organization know the community where the work takes place? Does the approach consider the unique characteristics of the community it serves?

Does the organization demonstrate the ability to collect and integrate feedback in an ongoing way from the people it aims to serve and other stakeholders?

• Leadership: Do the leaders within the organization demonstrate a strong history and commitment to the field of work and bring the necessary skills? Do they represent the populations they serve? Is the organization's leadership well-positioned to support the organization in scaling impact?

Grant Amount: Ten grants of \$1,000,000 each will be awarded.

**Eligibility:** Eligible organizations include:

- An organization recognized as a 501(c)(3) public charity by the Internal Revenue Service under the United States Tax Code.
- An organization recognized as a 501(c)(4) social welfare corporation by the Internal Revenue Service under the United States Internal Revenue Code.
- An organization recognized as a 501(c)(6) business league, or associated fiscal sponsor, by the Internal Revenue Service under the United States Internal Revenue Code.
- An organization that is not a charitable organization (including for-profit organizations) but whose proposal has as its primary purpose the accomplishment of a charitable purpose under the law or regulations of the United States Code and with respect to which no private interests will receive more than an incidental private benefit.
- Local organizations associated with national networks may apply so long as any award fund will go to the local affiliate.
- Post-secondary educational institutions.

The Lowe's Gives Foundation Supports Renovations, Grounds Improvements, Technology Improvements, and Safety Upgrades.

<u>Grant Amount:</u> Grants amounts range from \$2,000 to \$100,000.

<u>Eligibility:</u> The Foundation provides funding only to 501(c) (3) tax-exempt nonprofit organizations and public agencies in communities where Lowe's operates stores and distribution centers.

#### NEW!!

The Herb Block Foundation Accepting Letters of Inquiry for Programs Encouraging Citizen Involvement in Government.

The Herb Block Foundation is now accepting letters of inquiry (LOI's) for programs that encourage citizen involvement in government. The Foundation seeks to help ensure a responsible, responsive democratic government through citizen involvement. Proposals may focus on citizen education and greater voter participation in the electoral process. All projects must be nonpartisan and may not involve lobbying for specific legislation or candidates.

Grant Amount: Grants amounts range from \$5,000 to \$25,000.

<u>Eligibility:</u> Applicants must be nonprofit organizations classified as 501(c)(3) organizations by the Internal Revenue Service.

<u>Due Date:</u> Letters of Inquiry are due June 5, 2018, and the full proposal, if invited to apply, is due on August 8, 2018.

#### NEW!!

The U.S. Soccer Foundation Announces the Availability of Funds for Building or Enhancing a Field Space in an Underserved Community.

The U.S. Soccer Foundation is accepting Letters of Interest (LOI) for the 2018 summer grant cycle of its Safe Places to Play program, which provides grants to organizations to help them build or enhance a field space in an underserved community. Grants will be awarded in four categories: synthetic turf, lighting, irrigation, and sports court.

<u>Grant Amount:</u> Grant amounts vary depending on the category, but range from \$15,000 to \$50,000.

<u>Eligibility:</u> To be eligible, applicants must be a non-profit entity and own or hold a 10+ year lease on the field space, which must be majority-use for soccer. At the time of application, 50% of project funding must be in hand. A timeline is required, with a plan to complete the project within one year of the grant award.

As part of the LOI submission, applicants must obtain and submit an official project quote from the appropriate U.S. Soccer Foundation Corporate Partner(s) relating to the project. Appropriate partner(s) are designated by the U.S. Soccer Foundation. Solicitation for a quote should contain specifics of the project such as field measurements, including square footage, timeline, and the

- Don't require skaters or their parents to sign waivers.
- Encourage skaters to look after their own safety and the safety of others without restricting their access to the park or over-regulating their use of it.
- Are open during daylight hours, 365 days a year.
- Don't charge an entrance fee.
- Are in areas that currently have no skateboarding facilities.

Grant Amount: Grant amounts range from \$1,000 to \$25,000.

<u>Eligibility:</u> All applicant organizations must be a 501(c)(3) public charity, or a state or local agency planning on building a concrete skate park on public property. The <u>Fund for Shared Insight</u> is accepting applications from nonprofit organizations and grant-makers for its Listen for Good (L4G) initiative, which is dedicated to building the practice of listening in the sector.

L4G is focused on applying a semi-standard survey instrument, which includes using the Net Promoter System employed widely in customer feedback circles, to the nonprofit beneficiary context. Organizations implementing L4G are all customer-facing nonprofits. Since 2016, the fund has awarded one hundred and fifty-eight L4G grants supported by sixty-nine nominating co-funders.

The core feedback tool is a simple survey consisting of five standard questions that all participating L4G organizations are required to ask:

- 1. How likely is it that you would recommend [...] to a friend or family member?
- 2. What is [...] good at?
- 3. What could [...] do better?
- 4. How much of a positive difference has [...] made in your life?
- 5. How often do staff at [...] treat you with respect?

In addition, organizations can ask four optional demographic questions and add up to five custom questions to their survey.

The quantitative and qualitative responses to the L4G survey are gathered using a variety of data-collection methods — including kiosks, tablets, paper surveys, and in-person interviews — adapted in multiple languages, when appropriate. The survey-platform provider, SurveyMonkey, provides benchmarks to compare organizations' responses to those of organizations in similar issue areas. The fund also provides high-quality technical assistance to help organizations collect, interpret, and respond to feedback.

<u>Grant Amount:</u> Eighteen-month grants of \$30,000 as well as access to technical assistance will be awarded to program implementation.

The National Endowment for the Humanities Supports Digitization Events of Community Historical Materials Provided by the Public.

The National Endowment for the Humanities, through the Common Heritage Program, supports both the digitization of cultural heritage materials and the organization of outreach through community events that explore and interpret these materials as a window on the community's history and culture. The Common Heritage program considers a community to be a city or town (or a part of a city or town) that has been strongly shaped by geographical and historical forces. Members of the public in that community may have diverse family histories and heritage, or they may share a historical, cultural, or linguistic heritage. The program recognizes that members of the public—in partnership with libraries, museums, archives, and historical organizations—have much to contribute to the understanding of our cultural mosaic.

Together, such institutions and the public can be effective partners in the appreciation and stewardship of our common heritage. The program supports events organized by community cultural institutions, which members of the public will be invited to attend. At these events experienced staff will digitize the community historical materials brought in by the public. Project staff will also record descriptive information—provided by community attendees—about the historical materials.

Projects must also provide community outreach via public events that would expand understanding of the community's history or heritage. Public programs could include lectures, panels, reading and discussion groups, special gallery tours, screening and discussion of relevant films, presentations by a historian, special initiatives for families and children, interpretation by curators about items brought in by the public, workshops on preserving heritage materials, or other activities that bring humanities perspectives on heritage materials to community audiences. These activities must be rooted in the analysis of and engagement with humanities questions. The programs may take place before, during, and/or after the day of the digitization event.

Applicants must include in their proposals a humanities topic around which the event and the programs would be organized. Topics proposed for the public programs may also be proposed for the digitization event. The applicant institution must plan, promote, and organize the event and ensure that a wide range of historical materials can be digitized and also contextualized through public programming. Since the help of additional institutions and organizations in the community may be needed to accomplish this work, the applicant must take responsibility for enlisting appropriate organizations or institutions, such as local libraries and museums, to contribute to the project, as needed.

**Grant Amount:** Grants amounts range from \$1,000 to \$12,000.

Eligibility: Eligible applicants include:

- State governments
- Private institutions of higher education
- Public and State controlled institutions of higher education
- City or township or county governments
- Nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education

#### The National Archives and Records Administration Seeks Proposals to Publish Historical Records.

The National Archives and Records Administration, through the National Historical Publications and Records Commission (NHPRC), seeks proposals to publish documentary editions of historical records. Projects may focus on the papers of major figures from American history or cover broad historical movements in politics, social reform, business, military, the arts, and other aspects of the national experience. The historical value of the records and their expected usefulness to broad audiences must justify the costs of the project.

The goal of this program is to provide access to, and editorial context for, the historical documents and records that tell the American story. Applicants should demonstrate familiarity with the best practices recommended by the Association for Documentary Editing or the Modern Language Association Committee on Scholarly Editions. All new projects (those which have never received NHPRC funding) must publish a digital edition which provides online access to a searchable collection of all documents. (Ebooks or volumes in PDF do not qualify for the purposes of this grant program.) New projects may also prepare print editions as part of their overall publishing plan, but the contents of those volumes must be published online within a reasonable period of time following print publication.

The NHPRC encourages projects to provide free access to online editions. Projects that do not have definitive plans for digital dissemination and preservation in place at the time of application will not be considered. Grants are awarded for collecting, describing, preserving, compiling, transcribing, annotating, editing, encoding, and publishing documentary source materials online and in print. Because of the focus on documentary sources, grants do not support preparation of critical editions of published works unless such works are just a small portion of the larger project. All applicants should be aware that the application process is highly competitive.

Grant Amount: Grants of up to \$200,000 are available.

# The U.S. Department of Agriculture Supports Local Food Consumption and New Market Opportunities.

**Implementation projects** are used to establish a new local and regional food business, or to improve or expand an existing local and regional food business that will:

- Increase domestic consumption of and access to locally and regionally produced agricultural products; and
- Develop new market opportunities for farm and ranch operations serving local markets.

Such activities would include developing, improving, expanding, and providing outreach, training, and technical assistance to, or assisting in the development, improvement, and expansion of such businesses. Priority consideration will be given to projects that benefit communities located in areas of concentrated poverty with limited access to supermarkets and are implemented in and support agri-businesses located in rural areas or towns that have populations of 50,000 or less.

<u>Grant Amount:</u> Planning project grants range from \$25,000 to \$100,000 and Implementation project grants range from \$100,000 to \$500,000. Both planning and implementation projects require a 25 percent match of cash or an in-kind contribution of the total cost of the project.

<u>Eligibility:</u> Eligible applicants include agricultural businesses, agricultural cooperatives, Community Supported Agriculture (CSA) networks, CSA associations, economic development corporations, local governments, nonprofit corporations, producer networks, producer associations, public benefit corporations, regional farmers markets authorities, and Tribal governments.

The Administration for Children and Families Announces Funding for Collaborative Projects to Strengthen Families and Prevent Maltreatment.

The Administration for Children and Families' Children's Bureau announces funding for demonstration projects that support the development, implementation, and evaluation of strategies that embrace proactive efforts to build on the strengths of families, including those at high risk for child maltreatment, and enhance the capacity of communities to address the well-being needs of families before more formal intervention is warranted.

This program seeks to fund activities that include:

- the planning necessary to implement a multi-system collaborative among public and private agencies integrating community, faith-based, and non-traditional partnerships to support community-based and prevention-focused services for families, including those at high-risk for child maltreatment, and prevent child maltreatment from occurring;
- coordination of a network of community-based services and supports to foster the development of a continuum of maltreatment preventative services for children and families;
- a range of activities and services needed to maximize availability and access to resources using
  innovative approaches to leverage and coordinate existing funding streams to develop, adopt,
  implement, assess, and sustain effective community-based and prevention-focused services;
- wide-reaching mechanisms to identify high-risk children and communities, link families to community-based services, and empower families to support their children's healthy social and emotional development;
- active participation in rigorous site-specific and cross-site evaluations that include process/implementation, outcome, and cost study components; and dissemination of information about grantee experiences.

All applicants must identify local barriers to community-based prevention and family support services and implement innovative intervention strategies that mitigate or eliminate those barriers throughout the continuum of service to reduce the likelihood that future children will suffer maltreatment. The projects funded under this announcement will be implemented through strong multi-system collaboration among public and private agencies integrating community, faith-based, and non-traditional partnerships to support community-based and prevention-focused services that target high-risk families and prevent child maltreatment from occurring. Projects will facilitate cross collaboration and data sharing among relevant agencies.

The cooperative agreements aim to achieve three goals:

- 1. Implement innovative intervention strategies, informed by the relevant literature to reduce new and repeat referrals to the public child welfare agency by strengthening families and mobilizing communities;
- 2. Integrate efforts across public and private community groups and agencies in creating environments that support child and family well-being, reduce maltreatment, and strengthen protective factors; and
- 3. Vigorously evaluates these efforts to provide substantial information about the effectiveness of the programs, interventions, and practices implemented in reducing new and repeat referrals to the public child welfare agency.

Grant Amount: Grants amounts of up to \$500,000 are available.

<u>Eligibility:</u> The Children's Bureau welcomes applications from States, public agencies, private agencies or organizations, or combinations of such agencies and organizations. Applications from consortia and collaborations must identify a primary applicant responsible for administering the grant if the primary applicant is not the public child welfare agency. The applicant must document a strong partnership with the public child welfare agency with responsibility for supervising and/or administrating the child welfare program(s) in the targeted geographical area(s) and courts having jurisdiction over the targeted child welfare population.

The Secretary of Agriculture will determine on a case-by-case basis whether additional groups qualify

under this definition, either at the Secretary's initiative or in response to a written request with supporting explanation.

Grant Amount: Grants amounts range from \$1,000 to \$200,000.

<u>Eligibility:</u> Eligible applicants include Native American tribal organizations, nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education, public and State controlled institutions of higher education, and nonprofits that do not have a 501(c)(3) status with the IRS, other than institutions of higher education. All eligible organizations must have at least three years of experience working with socially disadvantaged farmers and ranchers or veteran farmers and ranchers. Organizations may either work with or have worked with one or both groups.

The central purpose of TVAP is to efficiently provide trauma-informed, person-centered, comprehensive case management services on a per capita basis to foreign national victims and potential victims of a severe form of trafficking in persons seeking certification so they can re-establish their ability to live independently. The awarded organization must provide comprehensive case management services to qualified persons either directly or through a network of providers, that provide direct services and/or community referrals. Trauma-informed, personcentered, case management must include but is not limited to, emergency assistance, housing, safety planning, basic needs, mental health services, employability services, legal services, medical care, access to benefits and services to the same extent as a refugee, and interpretation services.

Persons qualified for services under this grant include:

- A foreign national victim of severe form of trafficking in persons who is seeking or has received HHS certification
- A foreign national minor victim who is seeking or has received a letter of eligibility
- A family member in receipt of a derivative T Visa issued by the Department of Homeland Security (DHS)
- A minor dependent child of a victim of a severe form of trafficking in persons or potential victim of trafficking.

Grant Amount: Grants amounts not specified.

The Department of Labor Announces Funding to Support Adult and Juvenile Reentry Programs in High Crime, High Poverty Communities.

The Employment and Training Administration (ETA), U.S. Department of Labor (DOL), announces the availability of funding to enhance both adult and young adult reentry strategies through collaboration with the field to identify and respond to emerging or chronic reentry challenges. This funding provides organizations the opportunity to build customized projects.

Applicants must propose evidence-based and evidence-informed interventions, new interventions that theory or research suggests are promising, or a combination of both that lead to increased employment outcomes for their target populations. The Department is especially interested in

program models that offer apprenticeship opportunities. These apprenticeship opportunities include registered, industry-recognized, and pre-apprenticeships. Another focus of this initiative is to assist communities in planning and implementing comprehensive "reentry" programs to address the full range of challenges involved in helping formerly incarcerated adults and young adults who have been involved in the juvenile or adult justice system make successful transitions back to the community.

The intent of this initiative is to protect community safety by ensuring that these individuals:

- Become productive, responsible, and law-abiding members of society;
- Are provided with positive opportunities to engage in pro-social activities, such as employment and/or education;
- Maintain long-term employment;
- Sustain a stable residence;
- Successfully address their substance abuse issues and mental health needs, as applicable, through partnerships with local programs.

These projects will serve either young adults between the ages of 18 to 24 who have been involved in the juvenile or adult justice system, including high school dropouts, or adults ages 25 or older who were formerly incarcerated in the adult criminal justice system and released from prison or jail within 180 days of enrollment. Applicants may submit up to two (2) applications, a maximum of one (1) to serve adults and a maximum of one (1) to serve young adults. Each application may only propose to serve one target population, and applicants may not serve young adults and adults in the same program. Applicants may be selected to receive up to two (2) grant awards. All projects must serve high-crime, high-poverty communities.

Grant Amount: Grant amounts range from \$100,000 to \$700,000.

<u>Eligibility:</u> Eligible applicants must be community-or faith-based organizations with IRS 501(c)(3) non-profit status, including women's and minority organizations; state or local governments; or any Indian and Native American entity. The Department of Agriculture Supports Education and Extension Activities for Veterinarians and Veterinary Technicians.

The Department of Agriculture supports education and extension activities for veterinarians and veterinary technicians via the Veterinary Services Grant Program (VGSP). The VSGP is designed to support education and extension activities and practice enhancement initiatives that will enable veterinarians, veterinary students, veterinary technicians, and veterinary technician students to gain specialized skills and provide practices with additional resources (e.g., equipment, personnel) needed to more effectively mitigate veterinary service shortages in the U.S. Ultimately, this program will bolster the capacity of private practitioners to provide food animal veterinary services in designated rural veterinarian shortage situations.

#### Grants will be made to:

- Establish or expand accredited veterinary education programs, veterinary residency, and fellowship programs, or veterinary internship and externship programs carried out in coordination with accredited colleges of veterinary medicine.
- Provide continuing education and extension, including veterinary telemedicine and other distance-based education, for veterinarians, veterinary technicians, and other health professionals needed to strengthen veterinary programs and enhance food safety.
- Cover travel and living expenses of veterinary students, veterinary interns, externs, fellows, and residents, and veterinary technician students attending training programs in food safety or food animal medicine. Grants will also be made available to establish, expand, and better equip for-profit or nonprofit veterinary practices or individuals operating a veterinary clinic or providing veterinary services in a certain veterinarian shortage situation, as designated through the Veterinary Medicine Loan Repayment Program that is situated in a rural area.

Applications may only be submitted by the entities listed below if they carry out programs or activities that will either substantially relieve veterinarian shortage situations or support or facilitate private veterinary practices engaged in public health activities.

For all program areas, award recipients may subcontract to organizations not eligible to apply provided such organizations are necessary for the conduct of the project.

The Department of Labor announces funding for the Homeless Veterans Reintegration Program (HVRP). This program funds programs that array of client-focused services utilizing a case management approach that directly assists homeless veterans, as well as critical linkages for a variety of support services available in their local communities. The Substance Abuse and Mental Health Services Administration Accepting Applications for Assertive Community Treatment for Individuals with Serious Mental Illness.

The Substance Abuse and Mental Health Services Administration (SAMHSA), Center for Mental Health Services (CMHS) is accepting applications for fiscal year (FY) 2018 Grants to Establish and Expand Assertive Community Treatment (Short Title: ACT).

The purpose of this program is to establish or expand and maintain ACT programs for individuals with a serious mental illness (SMI). SAMHSA expects this program will improve behavioral health outcomes for individuals by reducing rates of hospitalization, mortality, substance use, homelessness, and involvement with the criminal justice system. ACT is considered to be one of the most effective evidence-based programs designed to support community living for individuals with the most severe functional impairments associated with SMI. Such individuals tend to need services from multiple

providers (e.g., physicians, social workers) and multiple systems (e.g., social services, housing services, health care). Based on the ACT model, a multi-disciplinary team is available around the clock to deliver a wide range of services in a person's home or other community settings. Recipients are expected to demonstrate the potential to achieve reduced hospitalization, homelessness, and involvement in the criminal justice system while improving health and social outcomes of participants in the program.

SAMHSA believes that only existing, experienced, and appropriately credentialed organizations with demonstrated infrastructure and expertise will be able to provide required services quickly and effectively. Additional requirements related to the provision of services are:

- A provider organization for direct client mental health services appropriate to the grant must be involved in the proposed project. The provider may be the applicant or another organization committed to the project. More than one provider organization may be involved;
- Each mental health treatment provider organization must have at least two years of experience (as of the due date of the application) providing relevant services. Official documents must establish that the organization has provided relevant services for the last two years; and
- Each mental health treatment provider organization must comply with all applicable local (city, county) and state licensing, accreditation, and certification requirements, as of the due date of the application.

Grant Amount: Grants of up to \$678,000 per year are available for up to five years.

<u>Eligibility</u>: Eligibility is statutorily limited to states, political subdivisions of states (e.g., counties, cities), Indian tribes or tribal organizations, mental health systems, healthcare facilities, and entities that serve individuals with SMI who experience homelessness or are justice-involved.

The Centers for Disease Control announces funding to implement the State Physical Activity and Nutrition Program (SPAN) to support communities to improve nutrition and to support safe and accessible physical activity. - Implement and integrate nutrition standards into statewide early care and education (ECE) systems such as quality rating improvement systems, state professional development systems, licensing, statewide technical assistance networks, state subsidy programs, statewide recognition programs, and others outlined in the CDC ECE opportunities framework. 1.
- Collaborate with partners to connect sidewalks, paths, bicycle routes, public transit with homes, early care and education, schools, worksites, parks, or recreation centers through implementing master plans and land use interventions. Establish new or improved pedestrian, bicycle, or transit transportation systems (i.e., activity-friendly routes) that are combined with new or improved land use or environmental design (i.e., connecting everyday destinations).
- Implement and integrate physical activity standards into statewide early care and education (ECE) systems such as quality rating improvement systems, state professional development systems, licensing, statewide technical assistance networks, state subsidy programs, statewide recognition programs, and others outlined in the CDC ECE opportunities framework.

# The Department of Health and Human Services Announces Funding for Family Planning Services.

The Department of Health and Human Services seeks applications from organizations that seek to establish and operate voluntary family planning services projects, which includes family planning services for both men and women as they plan their families. Such services include postponing, preventing, achieving, or facilitating the spacing of pregnancy. Family planning services also include infertility services, health screenings and exams, lab tests and related health services which are important to family planning and male and female reproductive health, improving the likelihood of a healthy pregnancy and birth, should conception occur. Family planning services also include information, education, and counseling related to family planning; and referral services as indicated.

Services under this grant will give priority to those from low-income families. An applicant may propose a family planning service project that either is comprised of a single provider or a group of partnering providers who deliver coordinated and comprehensive family planning services. If not

Single providers who have developed expertise in one family planning approach or method may be partners in a broader proposal that offers a broad range of family planning methods. Each project should offer core family planning services, including sexual health assessment; tools for personal family planning, fertility, and reproductive life plan; family planning services; health screenings; health information, education, and counseling; and referral services.

Grant Amount: Grant amounts start at \$150,000.

<u>Eligibility:</u> Any public or private nonprofit entity located in a State is eligible to apply for a grant under this announcement. The California Natural Resources Agency Announces Funding for Environmental Enhancement and Mitigation Projects.

The California Natural Resources Agency announces funding for Environmental Enhancement and Mitigation (EEM) projects. These projects must contribute to mitigation of the environmental effects of transportation facilities. The California Natural Resources Agency prescribes procedures and criteria to evaluate grant applications and submits a list of projects recommended for funding to the California Transportation Commission (CTC).

The CTC awards grants to projects from the Agency's list. Eligible EEM projects must fit one of the following categories:

- Urban Forestry projects designed to offset vehicular emissions of carbon dioxide.
- Resource Lands projects for the acquisition or enhancement of resource lands to mitigate the loss of, or the detriment to, resource lands lying within or near the right-of-way acquired for transportation improvements.
- Mitigation Projects beyond the scope of the lead agency responsible for assessing the environmental impact of the proposed transportation improvement.

Every EEM project must mitigate, either directly or indirectly, the environmental impacts of the modification of an existing Transportation Facility or the environmental impacts of the construction of a new Transportation Facility.

Grant Amount: Grant amounts of up to \$500,000 are available.

<u>Eligibility:</u> Any state, local, federal or 501(c)(3) non-profit entity may apply for and receive grants. The entity is not required to be a transportation or highway-related organization but must be able to demonstrate adequate charter or enabling authority to carry out the type of project proposed and be eligible for funding under Article XIX of the State Constitution. Partnerships are encouraged; however, only one entity may submit an application. Applicants may submit a one-page concept proposal. Though not required, this will help Applicants determine if their project may be competitive before completing a full application.
